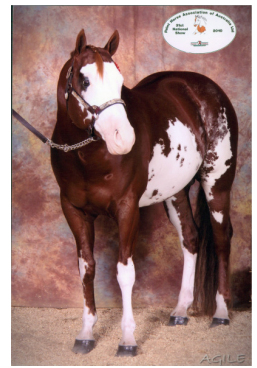


HYBROW Paint & Quarter Horses BREEDING CONTRACT

- SERVICE FEE:** \$660.00 Live Foal Guarantee (**conditions apply*)
- BOOKING FEE:** \$330.00 Deductible. Non-Refundable. Non-Transferable.
- BALANCE:** Payable upon collection of mare.
- AGISTMENT:** The agistment fee shall be \$15.00 per week. The mare owner agrees to pay all agistment fees before the mare leaves the property.
- VETERINARY CARE:** The mare owner agrees to pay all veterinary expenses incurred by the mare whilst in the care of the stud, before the mare leaves the property. The mare shall be in a healthy and sound breeding condition with hooves recently trimmed and free of shoes. All costs associated with pregnancy testing shall be met by the mare owner.
- LIVE FOAL:** Definition: A live foal will stand and nurse without assistance. If a live foal is not produced, a veterinary certificate must be provided within 7 days and the said mare is eligible for a free return in the next season. If the mare owner fails to provide the mare or substitute mare for a re breed the following year the stallion is released from any responsibility to re breed or refund any breeding fees and of any further obligation. It is also agreed that if the stallion dies or becomes unfit to breed, this contract shall become null and void. The mare owner agrees to pay for all agistment/transportation and veterinary expenses of the next season if they re breed. Mare owner agrees that Stallion owner does not make any guarantees as to the quality or conformation of the foal nor that the foal will be free of any inherited trait, infirmity, conformation defect or disease.
- COLOURED FOAL:** A coloured foal is deemed to be coloured if it shows any white markings above the knee, not including a blaze. There should be pink underlining skin which cannot be covered by a 50 cent coin and shall be deemed *registrable* by the PHAA. If a coloured foal is not produced the mare and only that mare shall receive a return service at no cost. Should the resulting foal not be coloured then the stallion owner is released from the contract and no stud fee will be sought from the mare owner.
****Paint and Quarter horse mares only eligible.***
- LIABILITY:** All care will be taken, but no responsibility will be accepted for any illness, accident, injury or death of the mare and/or foal, whilst in the care of the stud. Any amendments to or modifications of the terms of this agreement must be in writing.
- MARE REGISTRATION:** The mare shall be Paint, QH or ASB registered only. A copy of the mare registration papers shall be produced before the mare enters the property.
